## 1.1 INTRODUCTION

Established in the year 1880, Rajaram College, Kolhapur holds a unique position in the academic landscape of Western Maharashtra. The college is named after His Highness Rajaram Maharaj of Kolhapur state, who had a great zest for the spread of Education among the masses. Right from its inception, it has catered to the needs of students coming from all sections of society. Initially, Rajaram College was housed in the Building of the old Palace of the Maharaja in the heart of the City. It was later shifted in 1968 to the present building constructed on the vast expanse of 63 acres of the campus. It is run by the Government of Maharashtra under the Department of Higher and Technical Education. With the Motto- 'Quality Education for Personality and Nationality', it has been striving to achieve the holistic development of students through quality education. Further, it has been trying to contribute to the development of a pluralistic and multicultural nation. Some of the luminaries who figure in the list of our Alumni include Gopal Krishna Gokhale; Justice Mahadeo Govind Ranade -the noted Social Reformer; B.D. Jatti- the Ex Vice President of India; Y.B. Chavan- the Deputy Prime Minister of India; His Highness Shahaji Chhatrapati, Maharaja of Kolhapur State, Dr. J.P. Naik the architect of Kothari Commission; Dr. Vasant Rao Govarikar- the renowned Scientist and the Architect of NAAC Philosophy and Dr. Arun Nigavekar- the first Director of NAAC, Dr. S.B Mujumdar founder Symbiosis Pune, the winner of the 'Dnyanpeeth Award' and illustrious Poet Vinda Karandikar; the Chairman of NABARD, Dr. Yashvantrao Thorat-Patil; the first Olympic Bronze Medal Winner in Wrestling, Khashaba Jadhav and Gold Medalist in the Sport of Shooting at Asian Games of 2010, Ms. Tejaswini Sawant.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

Rajaram College Kolhapur follows the curriculum and academic calendar of Shivaji University Kolhapur. As per the University Academic Calendar, the IQAC, Academic Monitoring committee and the Department heads prepare the institutional academic calendar considering Curricular, Co-curricular Extra Curricular activities in view of the attainment of desired program outcomes (POs) and Course Outcomes (COs). Thereafter the departmental time table, syllabus distribution and teaching plan is carried out.

There is a multilayered monitoring system for ensuring effective implementation of the curriculum.

- Academic flexibility is offered by implementing CBCS pattern in **23** UG and **03** PG programmes.
- Bridge courses and orientation programmes are conducted in the beginning of every academic year to create awareness about the Programme Outcomes and Course outcomes.
- For effective curriculum delivery, faculties are encouraged to use innovative, student-centric methods such as seminars, projects, field survey, expert lectures, debates, group discussions, quizzes and along with the use of ICT tools and pedagogies.
- The Academic monitoring Committee and IQAC rigorously monitor and review the teaching learning and evaluation process throughout the academic year.

- The institution follows Continuous Internal Evaluation (CIE) process which involves Assignments, Unit tests, Orals, Seminars, Group discussions, Quiz etc

There is a well defined mechanism for the timely redressal of grievances regarding internal and external evaluation.

- In addition to the university curriculum, the college offers **39** Skill Development and Value Added Courses in order to equip the students with necessary employability and life skills.
- Besides the institution takes efforts for
  - the integration of crosscutting issues like sensitization of students to democratic values, political participation through the electoral process, the role of good governance in social well-being, social and economic justice, self-respect, equality, empathy,
  - Professional ethics involving integrity, punctuality, transparency,
  - Environmental conservation through 'reduce- reuse-recycle 'approach

There is a robust feedback mechanism to obtain the responses from all the stakeholders regarding the relevance and delivery of the prescribed curriculum.

### **Teaching-learning and Evaluation**

Teaching, learning, and evaluation are the core activities of the our institution. Teaching facilitates knowledge transfer, fostering critical thinking and skills development. Learning empowers students to absorb information, cultivate their intellectual curiosity, and apply concepts in practical scenarios. Evaluation ensures students' progress and enables teachers to modify the pace and method of curriculum delivery.

The overall student enrolment ratio of the institution is 94 % in the last five years. All the government directives including reservation policy are strictly followed in the admission procedure. 70 % of reserved seats have been filled in last five years. The institution fosters Student diversity. The teacher-student ratio is 1:47 for last five years and 95% of the faculty members posses NET/SET/Ph.D. degree.

The institution is keen about creating student centric teaching-learning environment. The student centric methods of experiential learning, participative learning and problem-solving are extensively used. All the departments take efforts to ensure that students 'see', 'observe' and 'experience' what they learn in books. Participation of students in the curriculum delivery is ensured to enhance the interest of the students in learning. As the institution has strong ICT infrastructure, the faculty members use ICT enabled tools in teaching process.

The mechanism for internal and external assessment is transparent and efficient. Under the guidance of the Principal, the College Examination Committee monitors the effective conduct of all internal and external examination activities. Examination related grievances, if any, are addressed in time-bound manner.

The institution is committed to Outcome Based Education. POs and COs are communicated to the students by various methods including display on website, notice boards, orientation sessions, etc. Further, the attainment of these POs and COs is evaluated through summative and formative assessments. The mapping of COs and POs is done by employing a statistical tool and outcome gaps are identified and necessary measures are taken to overcome those gaps. The average pass percentage of students in the last five years is above 90%. The institution encourages the students to participate in the Online student satisfaction survey regarding the

teaching learning process.

## Research, Innovations and Extension

Our institution is actively engaged in Research, Innovation and Extension activities.

- There are 07 recognized labs for conducting research. Besides, funding of Rs 50,00,000 has been received from RUSA for the development of Common facility Centre.
- In the last five years 18 research projects are being undertaken in the institution for which the funding of Rs. 24,55,973/- has been granted by various funding agencies like UGC, UGC-DAE-CSR, DAE-BRNS, MoEFCC etc.
- Our institution has created conducive environment for research by establishing Innovation, Incubation and IPR Cell to nurture new ideas. 03 collaborative Industrial projects, 02 individual projects by faculty members, 05 application based projects by students have been completed and 01 startup project is going on.
- To create awareness regarding IPR, 05 seminars/webinars and 03 entrepreneurship development related activities have been conducted so far.
- 02 patents have been filed and 02 copyrights have been conferred as a recognition of the innovative work carried out in the institution. The cell also fosters academy- industry interaction.
- Our institution is committed to continuing the legacy of Indian knowledge system (IKS) and to apply traditional methods to contemporary issues. In view of this various steps have been taken to preserve and to promote the traditional Indian culture.
- More than 149 research articles have been published in international / national journals since the last accreditation. 06 books with ISSN number, 02 modules and 01 book chapter have been edited by our faculty members. The highest average h-index achieved by our faculty is 26.
- In lieu with research activities, college is focused on social and extension activities too.
- NCC and NSS units are consistently rendering their services in the various fields namely environmental awareness, social responsibility, awareness about Covid-19, gender equity, etc. 67 activities were organized by college NCC, NSS units, various departments and few in collaboration with NGOs.
- 28 awards have been received by our Faculty members from national and international agencies in recognition of their research and extension activities.
- 23 MoU's and 11 Collaborations have been signed with academic and research institutes, industries and non-government organizations which opens diverse avenues for holistic development of students.

## Infrastructure and Learning Resources

Our college is situated on a sprawling campus measuring 63 acres with state of the art infrastructure. The infrastructural facilities available in the institution include :

- Classrooms: In all there are 35 classrooms out of which 03 are smart and 12 are ICT enabled classrooms. Smart Classrooms are well equipped with interactive panels and other IT facilities
- Laboratories: There are in total 22 laboratories are equipped with UV-Vis, Infrared, PCR, Cooling Centrifuge, Research Microscopes, and more.
- 07 Labs are recognized for Ph.D work
- The central library- 'Balkrishna Granthalaya' is fully automated and has a huge collection of rare books and manuscripts in various languages such as Marathi, Pali, Sanskrit, Ardhamagadhi, Kannada, English.

The library repository currently includes 1,06,230 books. Integrated Library Management Software SOUL 3.0 (Software for University Libraries) designed by UGC INFLIBNET is used for cataloguing and circulation of volumes. All the books are all digitally catalogued, and the database is incorporated with the ILMS.

- IT Facilities: College frequently updates its IT facilities. There are three 100mbps optical fibre connections with LAN facility • Computer centre cum Language Lab with 54 computers • 75 computers for departmental, academic and administrative work • LCD projectors, Wifi capability in departments,
- Other Facilities: • Separate Administrative building • Yashwantrao Chavan Sabhagraha of 720 capacity • Open Amphitheatre • Open Canteen facility • Museums in Botany, Geology and Zoology departments • Ladies room • Gymkhana building with well-equipped gymnasium, indoor badminton wooden court. Multipurpose ground with 400 M running track • 100 Boys Hostel • 50 Girls Hostel • 100 capacity Minority Girls hostel
- 02 Rector Bungalows • Teaching and Non-Teaching Staff Quarters • Principal Bungalow • Separate Cells for Examination, NSS, NCC, etc.
- Greenhouse with glass dome, Vermicomposting Unit, Rainwater Harvesting Units, Oxygen Park, Power Generator of 60 KVA capacity.
- Being a government institution, its entire infrastructure is managed and maintained by Public Works Department (PWD), Government of Maharashtra. The total spent on the maintenance of the infrastructure for the last five years is more than 142 lacs.

### **Student Support and Progression**

The institution keenly focuses on holistic development of students through continuous student support aiming at their steady progression in their chosen fields.

Student Support:

Scholarships and freeships- The percentage of students benefitted by scholarships from Government and Non-Government funding agencies is 17.86%.

In all 45 capacity-building and skill-enhancement courses including value education, soft skills, communications, and ICT skills have been organized in last five years

The Career guidance, Competitive examinations Cell have provided guidance and counselling to 8887 students.

The institution has adopted zero tolerance policy and is executed through statutory bodies like Anti-Ragging Cell, Internal Complaints Committee, and a Student Grievance Redressal Cell for ensuring safe and secure environment on the campus.

Student Progression:

In the last five years the percentage of placement and progression is 40.78%.

917 students have advanced throughout the past five years, 214 students who have been placed.

In the past five years, 77 students have passed competitive exams including GATE, UGC-NET, SET, IIT-JAM,

etc.

256 NCC cadets have passed their B certificates, and 202 have earned their C certificates.

Student involvement and activities: Students have won 95. prizes and medals at the international, national, state, zone, and collegiate levels for their participation in sports and the arts.

There are student representatives on the IQAC, cultural, and other committees.

The number of cultural and sports programs in which students of institution participated are 58.

Engagement of Alumni: Rajaram College alumni have formed the Rajaram College Past Students Association (RACOPASTA) to maintain a strong connection with their alma mater. The association, established in 1979, has around 5,000 registered members. Their aim is to support the college in academic development, student support, and infrastructure improvement. Eminent alumni interact with current students, share knowledge, guide career paths, and encourage self-improvement. Donations and collaborations with alumni-owned firms, industries, and NGOs benefit students, providing training, workshops, and resources. Alumni have contributed to the college library, developed gardens, installed irrigation systems, and supported rainwater harvesting. They also organize the annual Rajaram Mahotsav, a gathering promoting intellectual growth, cultural values, and social activities, which receives financial support from the alumni association.

### **Governance, Leadership and Management**

Rajaram College, Kolhapur is solely run by the Government of Maharashtra. the hierarchical structure of the institution begins with Hon. Chief minister followed by Hon Minister of Higher and Technical Education, the Principal Secretary, Deputy Secretary, the Director of Higher Education and the Principal. Under the guidance and supervision of all these higher authorities the Principal, being the head of the institution, acts as the chief planning and implementing authority. The college deploys the strategies of decentralization and participative management for preparing and implementing the institutional perspective plan based on the vision, mission and goals of the institution.

The institution has implemented e governance in various academic and administrative operations such as admission, evaluation, Scholarships, Payroll and other support services. The institution follows the rules and regulations as stipulated by UGC, State government and the affiliating University.

The institution has in place a rigorous and multi layered performance appraisal system which ensures consistent quality enhancement of teaching and non-teaching staff. Also there are effective Welfare measures for the timely promotion and progression of the teaching and non-teaching Staff. Through institutional encouragement 47.33% faculty members have participated in various professional development and administrative training programs in the last five years.

The institution has received financial support of Rs.7,80,40,272/- from various agencies like RUSA, DPC, Plan and Non Plan grants from state Government. The optimal utilization of allocated funds is done by strictly following the financial norms stipulated by the state government as well as concerned funding agencies and it is reviewed through Internal and external audits are conducted by competent authorities.



The IQAC sets quality benchmarks and conducts regular meetings for initiation of innovative practices and reviewing the teaching –learning process. It has conducted internal and external Academic and Administrative Audits. Other Quality assurance initiatives of the IQAC include: 63 Add on courses , 53 MoUs and Collaborations, and Participation in AISHE, ATAL and DBT star college. Apart from this the IQAC is actively engaged in organizing a host of activities for the effective implementation of the institutional perspective plan as well as the achievement of the set vision and mission.

### **Institutional Values and Best Practices**

Rajaram College has always nurtured strong institutional values and evolved exceptional best practices. The College conducts the ‘Institutional Gender Audit’ on a regular basis through internal and external bodies. For ensuring gender equity, all the rules and regulations regarding women reservation are followed.

Being a premier institution in the region, we decided to reach out to the schools located in rural and the remote areas for providing better exposure to emerging avenues and horizons in the arena of science and technology through this practice. This also helped our students to present their knowledge through demonstrations, models, ppt, etc.

#### **2. Research Sensitization:**

The institution motivates its students and faculty to engage in research consistently. Our college has constantly strived to create congenial atmosphere for various research activities. For this, seminars, workshops, conferences are arranged.

**Institutional Distinctiveness:**

Rajaram College organizes a unique programme entitled “Rajaram Mahotsav”- a programme where both the past and present students get together for enriching one another. Eminent past students are invited to interact with the present students, parents and other stakeholders. Another aspect of institutional distinctiveness is its outstanding performance in Youth Festival, National integration Camps and Sports. Similarly, our college is consistently working in collaboration with various institutions, professional bodies and non-governmental organizations for ensuring the holistic development of the students and significant contribution to the neighborhood community.

The Choice Based Credit System (CBCS) is followed for all undergraduate as well as postgraduate programs. As college offers Arts, Commerce, and Science curricula, students have full range of options specified by the CBCS pattern. However the college has introduced two interdisciplinary courses at the undergraduate level namely Nanotechnology, Astrophysics and Space Science. At the same time, it is encouraging faculty members for adopting this approach in their academic and research activities. The institution has formed the committee for monitoring the implementation of "National Education Policy-2020". This committee is supposed to develop a perspective plan and devise an appropriate mechanism in order to follow an approach that draws from multiple disciplines. As per the guidelines of NEP 2020 the institution has decided to focus on diversity in the curriculum and pedagogy, the incorporation of technology advancements in learning and instruction, the promotion of rational decision-making and innovation, as well as critical thinking and creative problem solving.</p>
<p>2. Academic bank of credits (ABC):</p>	<p>The institute has taken the initiative to aware all the stakeholders about the Academic Bank of Credits (ABC). The registration process for ABC is communicated to students via the college website and a notice. As a state university, Shivaji University, Kolhapur is an official member of the National Academic Depository, a Digital India Programme initiative to provide an online repository for all academic distinctions. The parent university has already started the registration process on the nad.digitallocker.gov.in portal via its affiliated colleges. After the resolution is ratified by university, our institution has constituted the committee headed by the Nodal Officer. This committee to create ABC IDs for the first year students and keep track of the same. The Students are guided about the ABC registration process via the college website and notice. The Institute is in the process of building a centralised database of students for this purpose. Through this database, the academic credits acquired by the student from various courses will be digitally maintained so that the credit gained earlier by the student can be accumulated when the student re-enters the programme.</p>

Skill development:</p>	<p>Our institute inculcate a sense of pride in our unique legacies of traditional Indian knowledge systems and strives to integrate traditional knowledge into modern contexts. As mandated in the National Education Policy 2020, the core areas of IKS such as health and</p>

In this regard, the following measures have been taken: Degree programmes incorporated with add on courses that preserve and promote Indian languages, ancient traditional knowledge, arts, culture and traditions. Rare manuscripts in Sanskrit Ardhamagadhi, Pali, Persian, Urdu, Kannada, Marathi, and other languages are being preserved. Preservation of a great treasure trove of ancient and mediaeval literature in the shape of religious texts, historical documents, monographs, maps, etc. Introduction to Modi Script: Promotion of traditional art through training programmes for Terracotta, bamboo, and paper goods. The preparation of Ayurvedic products Cosmetics made from herbs. displays and demonstrations of traditional wild veggies Plant-based edible colours and festival colours. Traditional culture is promoted through various programmes and competitions such as folk dance, painting, and so on. The institutional magazine is published in sections for content in various languages, including English, Marathi, and Hindi.</p>

Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):</p>	<p>In accordance with the National Education Policy 2020, which places an emphasis on Skill Development as a key component that needs to be worked on. The institution has already begun developing and providing students with skill-based courses which attract a sizeable number of students. The skills that are acquired cover a broad spectrum, from interpersonal skills to information and communication technology abilities. Considering the holistic development of students, the college offers 39 Add-on courses, including value added, linguistic, Soft skills and skill enhancement courses. Focus on Outcome based education (OBE):</p>	<p>Our institution aims at Outcome-based education (OBE) which is a method of measuring learner outcomes that focuses on identifying and measuring the information, abilities, and attitudes that students should have as a result of their education. The emphasis in an OBE system is on student learning and the results that students are expected to attain, rather than on traditional teaching and instructional methods. Our institution being affiliated to Shivaji University Kolhapur, follows the university's curriculum which assigns Programme Outcomes (POs), Programme Specific Outcomes (PSOs), and Course Outcomes. These outcomes are displayed on the college website and notice boards, and they are also presented to students through coursewise orientation sessions held by respective faculty members. To attain the learning outcomes, faculties are advised to employ novel pedagogical strategies in teaching-learning practises. POs, PSOs, and COs are estimated using both summative and formative approaches. Continuous assessment methods like seminars, study tours, workshops, quiz, Group discussions, Surveys etc. are planned with particular objectives in view. The institution organizes various curricular, Co- curricular and Extra-curricular activities to ensure the attainment of outcomes.</p>
<p>6. Distance education/online education:</p>	<p>As a result of the Covid -19 outbreak, higher education institutes across the country have shifted their focus to online learning and virtual conferences and meetings. Using platforms like Zoom and Google Meet, teachmint etc our institution successfully delivered all course content online throughout the Covid-19 pandemic. **The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment**

##### **Response:**

Our college follows the curriculum and academic calendar designed by the affiliating University, viz. Shivaji University, Kolhapur. It implements Choice Based Credit System (CBCS) pattern for all the undergraduate and post graduate Programmes. It also offers non-credit courses namely, 'Democracy, Election and Governance', 'Personality Development', 'Environmental Studies', 'Constitution of India', and 'Interview Skill and Presentation Techniques'. Ph.D. Programmes are also run in Botany, Chemistry, Microbiology, Physics, Home Science, English, Geography, Economics, and Psychology. The detailed information about all the programmes and the courses available in the institution is published through the college prospectus and the college website.

##### **Curriculum Planning:**

Focusing on outcome based quality education, the college has set high quality benchmarks and has adopted well-defined Curriculum planning and implementation strategies like:

- Well designed institutional academic calendar
- Integrated curricular activities
- Well suited Co-curricular activities
- Multi-layered Monitoring and Continuous Evaluation
- Robust Research and pertinent extension activities

The Institutional academic calendar is prepared along the lines of the calendar of Shivaji University, Kolhapur. All the departments of the institution plan their curricular and co-curricular activities for achieving desired Programme Outcomes (POs) and Course Outcomes (COs).

##### **Curriculum Delivery:**

Innovative pedagogical methods such as participative learning and experiential learning are integrated into the traditional classroom curricular delivery. ICT enabled educational tools including LMS, e-content and smart classrooms are effectively used to enhance the learning experience of the students. Seminars, projects, field survey, expert lectures, ready reference, debates, group discussions, quizzes, etc. are conducted on a regular basis.

Catering to the diversity of the learners is one of the key strategies to ensure effective curriculum

delivery. At the beginning of every academic year, Orientation sessions and Bridge Courses are organized for all the new entrants to bridge their knowledge gaps and special efforts are made for catering to the needs of slow and advanced learners in the college. The institution promotes advanced learners to take part in a variety of activities, such as seminars, workshops, training sessions, and competitions for research project ideas, in order to obtain significant experience. In addition to the books available in the central library as well as departmental libraries, advanced learners are also encouraged to obtain additional study materials through e-resources.

The Feedback regarding the curriculum and its delivery is obtained from the stakeholders. It is analysed by the committee and conveyed to the IQAC and the head of the institution for necessary action.

Continuous Internal Evaluation (CIE) is an integral part of the academic calendar. The CIE uses different examination methods such as unit tests, home assignments, quizzes, open book tests, powerpoint presentations, group discussions, field work, projects, etc. The final assessment is done at the end of every semester by integrating internal assessment with the university examinations.

All the Course Outcomes, Programme-specific Outcomes, and Programme Outcomes are assessed continuously by the Heads of the Departments, IQAC and the Principal.

## 1.3 Curriculum Enrichment

### 1.3.1

*Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum*

**Response:**

The college functions within the curricular framework set by the affiliating University and integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment, and Sustainability into the Curriculum. It is one of the objectives of the college to create globally competent students and integration of crosscutting issues in curriculum helps in achieving this goal. These issues are also integral part of Programme Outcomes.

- **Curriculum Framework:** Several faculty members of the college work on the Board of Studies of the affiliating university and also on BoS of other Universities and Autonomous Colleges. They take efforts for integration of crosscutting issues in the curricula and in new courses being introduced. The prescribed syllabus of social sciences contains many units that deal with awareness about gender, caste, regionalism, and language-related issues. For instance, poetry, plays, and novels in Marathi, Hindi, and English languages enlighten the students on social realities. Social sciences curricula deals with gender and violence, domestic violence, harassment of women at work place (Sociology), feminism, civil society, youth, depressed classes, peasant movement and Indian politics (Political Science and History), dietary modifications for pregnant, lactating and anemic women, adolescence, women entrepreneurship (Home Science), Poverty, development (Economics) etc.
- **Compulsory Non-Credit Courses:** The affiliating university prescribes three compulsory non-credit courses, namely Democracy, Election and Good Governance; Indian Constitution; and Personality Development. These courses are designed to sensitize students towards democratic values, political participation through the electoral process, the role of good governance in social well-being, inculcating values related to political, social and economic justice, self-respect, equality, empathy, and professional ethics like integrity, punctuality, transparency, etc.
- **Add-On Courses:** The institution has integrated some issues in its add-on courses, like the Department of Sociology's add-on course on Social change and Human Beings, and the Department of Political Science's course on Nationalism and Citizenship. Department of Psychology has introduced course on 'Psychology for living'.
- **Environment Studies:** The College has made Environment Studies a compulsory course for B.A. II, B.Sc. II and B.Com. II students and field-based projects are assigned to all the students related to environmental issues. Several aspects regarding environmental consciousness, biodiversity, and sustainability are studied as part of syllabi of Zoology, Botany, Microbiology, Geology, Chemistry, and Geography.
- **NCC-NSS Units:** The institution strives to inculcate these values through activities undertaken by the NCC-NSS units. These activities include tree plantation drives, cleanliness drives, awareness programs, and rallies on environmental issues, AIDS awareness, and other social issues.
- **Departmental Clubs and Associations:** Various departmental clubs and associations also undertake activities that help in sensitizing the student community towards crosscutting issues. Departmental associations organize lectures, seminars, and workshops on gender, human values, and environmental issues.

Through its various initiatives, the college provides its students with a holistic and well-rounded education that goes beyond mere academic excellence.

Our institution is keen on creating learner-centred and individualised teaching-learning environment. For this purpose, various student centric methods are used:

### **Experiential learning:**

When theoretical knowledge is coupled with experience-based erudition, remarkable learning outcomes are achieved. This helps students to 'see', 'observe' and 'experience' what they learn in books through the following-

- Projects
- Field Survey
- Study Tour and field Visits
- Industrial Hands on Training
- On Job Training
- Laboratory Experiments

### **Participative Learning:**

Participative Learning is encouraged by enhancing the role of students in curricular planning and delivery. Students are encouraged to be inquisitive in class and on the LMS platform, express their opinions, and share their ideas by means of the following-

- College Annual Magazine,
- Seminar Presentation
- Lead College Activity
- Poster Presentation
- Role playing, Debates and Elocution Competition
- Research Competitions like Avishkar, Anveshan etc
- Departmental Club Activities

### **Problem-Solving methods:**

The Problem-solving methods such as-

- Open Book test,
- Group discussions
- Quizzes
- Brain storming sessions on social, economic and political issues
- Field reports on issues like Disaster Management, Biodiversity Conservation, etc

- are incorporated into pedagogy to cultivate a critical mind and spirit of innovation. Students are asked to discuss and work on open-ended classical problems in various subjects. The focus of the activity is not on finding a definite solution to a problem but to develop skills and attributes such as scientific temperament, group collaboration and effective communication.

### **Use of ICT-enabled Tools:**

Our faculty members use ICT-enabled methods and tools to provide an enhanced learning experience and ensure multi-modal delivery of knowledge. It also simplifies access and understanding of course material for students. To achieve this college has trained its faculty members and developed adequate ICT infrastructure.

Training sessions on the use of Google Classroom LMS, lecture video recording and editing were organized for the teachers. This has helped to extend the teaching-learning process outside the physical constraints of the classroom and teachers continue to provide educational inputs to students almost around the clock. Teachers have also developed Educational YouTube channels, web portals and blogs.

WiFi as well as LAN facility is made available to all the stakeholders on the college campus. A Multi-Media Centre with 55 computers connected to high-speed internet is available to students. Interactive panels with a wide range of illustration options are installed in several classrooms. LCD projectors are also installed in other classrooms to enable the audio-visual presentation of diagrams, models and documentaries to students. A lecture recording facility equipped with an interactive panel, PTZ camera, audio recording equipment, and lighting is developed.

E-resources including those available on NList, e-PG Pathshala, CEC, and NPTEL are referred to the students. Online spoken tutorials program is organized in association with IIT Powai for courses like Scilab, Cell Design, Chem collaborative Virtual lab, and LaTeX. Also, AMI online lectures, and online IIRS-ISRO programmes on SARS remote sensing, machine learning, Health GIS and Satellite Photogrammetry are organised.

## 2.5 Evaluation Process and Reforms

**2.5.1**

**Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**

**Response:**

Rajaram College has robust mechanism for the conduct of internal as well as external assessment. The Continuous Internal Evaluation is a formative assessment method adopted by our institution to monitor the learning level of each of the students. External assessment is a summative assessment by the affiliating university to evaluate the learning level of students.

At the end of each semester, the final grade is determined by combining internal assessment with university examinations. The key features of the assessment mechanism are as under:

**Efficient mechanism for evaluation:**

The College Examination Committee is in place for smooth conduct of all the examinations. It defines the nature and the schedule of internal assessment for every semester and monitors the entire process ensuring timely declaration of the results. As regards external evaluation, the institution strictly follows rules and regulations set by the affiliating university. The faculty members work as paper setters, examiners, supervisors and moderators during this process and discharge their assigned responsibilities throughout the academic year.

**Development-inducing feedback:**

The institution follows Continuous Internal Evaluation (CIE) system which helps in addressing the specific needs of students. The teachers are encouraged to provide personalised development-inducing feedback to the students after each round of evaluation. It helps in customizing the pace and method of curriculum delivery. Internal as well as external assessment is conducted in order to gauge the level of achievement of Course Outcomes and Programme Outcomes of the learners.

**Transparency in the system:**

The internal assessment is conducted fairly and timely. Transparency is maintained in the internal assessment by providing a model answer key on the completion of tests. Re-tests are conducted for the students who fail to appear for the test as per the given schedule for genuine reasons. Teachers use innovative evaluation methods in the internal assessment to enhance the efficiency and effectiveness of the process such as open book-test, seminar presentations, poster presentations, etc. The sanctity and confidentiality of the overall examination process is maintained by our institution.

**Effective grievance Redressal System:**

There is an effectual mechanism for time-bound redressal of grievances regarding internal and external evaluation:

**Mechanism for internal examination grievances redressal:**

The grievances of students related to internal assessment are initially addressed by the subject teacher. However, if a student is not satisfied with the resolution provided by the subject teacher, he/she can submit a written application to the respective head of the department and the college examination committee.

**Mechanism to external examination grievances redressal:**

**Administrative grievances:**

- In case of errors during filling up the online examination forms, the students are free to approach the examination desk in the college office. The error is communicated to the University examination section immediately and rectifications are carried out.

**Technical grievances:**

Grievances related to the marks obtained by the students in the external examination are addressed as per the procedure set by the university. Students can apply in the prescribed format for a photocopy of the assessed answer book/s and their marks can be upgraded after rechecking and reevaluation.

**2.6 Student Performance and Learning Outcomes****2.6.1**

*Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website*

**Response:**

Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (COs) are the basic set of concepts, knowledge, skills, and attitudes acquired by the students on successful completion of a specific course/Programme. While designing the syllabus of a particular course, the Board of Studies of affiliating university specifies the broad outcomes that are expected to be achieved by the students who opt for the course. These course outcomes are explicitly mentioned in the syllabus of the course. However, the Programme Outcomes (POs) are broad in their approach and encompass the development of various human faculties.

As per the philosophy of Outcome Based Education (OBE), our institution expects that by the end of a course or a programme, each of our students must achieve certain attainment targets. These targets are essentials for learners to successfully do at the end of their learning experience. In this regard, the institution seeks to imbibe a set of attitudes and skills in students. The set includes life skills, professional and vocational skills, intellectual skills, and interpersonal and personal skills.

The stating of POs and COs benefits in providing clarity of what needs to be accomplished at the end of the course/programme, provides flexibility in implementing a student-centric learning model and opportunity for involvement in curriculum planning – implementation.

Our institution has adopted the following mechanism to make all the stakeholders aware of the Programme and course outcomes:

1. All the Programme Outcomes and Course Outcomes are stated and displayed on the college website.
2. The outcomes are also displayed on the department notice boards for the information of all the stakeholders.
3. The Programme and course outcomes are discussed by faculty members during the departmental meetings at the initiation of each semester.
4. The Programme outcomes are explained to the students during the orientation programme which is conducted at the beginning of the programme. Similarly, students are given thorough knowledge about the expected course outcome by the subject teachers during the initial introduction to the course in the class.
5. Teachers also share the course outcomes with the students through Google Classroom and other digital platforms.
6. The Programme outcomes are also displayed in the college library.

The attainment of POs and COs is evaluated by the institution to monitor learning levels and to identify gaps in the learning outcomes. An MS Excel-based statistical model is developed at the institutional level to analyze the performance of each of the learners. The model synchronizes analysis of the attainment of Course Outcomes to cumulatively arrive at the attainment of Programme Outcomes. In this, the performance parameters of the student in the external term-end examination are mapped with his performance in internal assessment and participation in various other activities.

### 2.6.2

*Attainment of POs and COs are evaluated.*

**Explain with evidence in a maximum of 500 words**

**Response:**

In Outcome Based education (OBE) system, emphasis is placed on the attainment of clearly articulated Programme Outcomes (POs) and Course Outcomes (COs) that the students are expected to achieve during their educational experience. Our institution constantly strives to ensure the attainment of POs and COs for every student and the level of attainment is regularly evaluated to improvise the curriculum delivery and the capacity of learners.

**Methodology of evaluation:**

A statistical method is used to evaluate attainment of POs and COs with 60% weightage for summative assessment and 40% for the formative. As certain qualities and quantities of outcomes are clearly identifiable while others are abstract, unseen and intangible in outcome-based education, the

analytical model of evaluation combines directly measurable objective factors as well as indirect quantities based on subjective perceptions. For variables where direct measurements are not feasible, the concept of indicators is adopted. The COs for most of the courses are objectively quantifiable but the POs are subjective in nature and require perception and opinion-based inputs to evaluate. The mapping of COs and POs is done by employing a statistical tool which is an Excel sheet-based measurement system. The tool is regularly revised to make it scalable, accurate, automated and capable of handling longitudinal data. The Outcome analysis helps the institution to locate gaps and adopt remedies that ensure continuous improvement.

#### **Parameters of evaluation:**

The COs are evaluated by considering the performance of learners in the summative assessment conducted by the university at the end of each semester. The institutional benchmark for the attainment of each student is scoring at least fifty per cent marks in each of the courses offered. While mapping COs in the rubric, the total weightage of **60 %** is allotted to it.

For the evaluation of POs, a wide variety of factors is explored where internal assessment is the most important component. Our teachers use innovative evaluation methods in the internal assessment to enhance efficiency and effectiveness of the assessment process. These include open book tests, seminar presentations, poster presentations, multiple choice questions tests, group discussions, quizzes, Viva Voce and projects. These are helpful in assessing the attainment of Programme Outcomes (POs) comprising intangible skills and attitudes. The attainment of programme outcomes like Ethical behaviour, effective communication, teamwork, critical thinking, scientific temperament etc. are judged through group discussions, presentations, and Viva-voce. The participation and performance of students in various department activities are also factored into the rubric. An indicator based on these two aspects is included in the rubric with a weightage of **40** per cent.

Apart from the statistical tool-based analysis, some additional methods are used to evaluate COs and POs. For example, a institutional student satisfaction survey is conducted in order to register student's educational experience regarding their choosen Programme and Courses. In addition, some departments assign, a Capstone Project based on the programme curriculum to students by means of which the students can apply the knowledge and skills obtained through their programme.

#### Response:

Our college is spread on a picturesque area of about 63 acres. It has an eco-friendly and secured campus with academic ambience and excellent infrastructure. The college has adequate infrastructure with separate buildings for departments of Chemistry and Physics, Botany and Zoology, Geology and Geography, Microbiology and Industrial Microbiology and Home-Science. Mathematics and Statistics departments are housed in the main building. The buildings have been so designed to have separate classrooms and laboratories for these departments.

Departments of Arts and Commerce wings are housed in the two – storey Main Building of the college. This building has six large classrooms with 120 seating capacity.

The college has a separate two-storey Building for the Central Library. The library building houses a spacious study room, Multi-media centre cum Language Lab with 55 computers, Video Conferencing Room.

#### 1. Classrooms Facilities:

**4.2 Library as a Learning Resource****4.2.1**

*Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students*

**Response:**

The central library of the institution is named as 'Dr. Balkrishna Granthalaya'. The library is housed in a spacious two storied building having 15000 Sq. ft area. Being one of the oldest libraries in Maharashtra, it has a huge collection of rare books and manuscripts in various languages such as Marathi, Pali, Sanskrit, Ardhamagadhi, Kannada, English. The library repository currently includes **1,06,230** books in four different sections.

**Automation of the Library:**

The library is fully automated with appropriate digital facilities. The cataloguing and circulation of books is done using state-of-art Integrated Library Management Software SOUL 3.0 (Software for University Libraries) designed and developed by the UGC's INFLIBNET Centre. All the books available in the library are digitally catalogued and the data-base is integrated in the ILMS. The books are location-tagged and barcode-marked to ensure speedy and accurate circulation. Users can determine the availability of specific book by utilizing Simple or Booleans search options available on the On-line Public Access Catalogue (OPAC) module.

**Subscription to e-Resources and Journals:**

The library ensures availability of good quality e-content by obtaining institutional subscription to repositories like N-List and EBSCO essentials. Under N-List more than 6000 journals and 1,99,500 e-books are made available to students, researchers and faculty members. Additionally, 25 reputed journals and magazines in print format are subscribed and are available to users in the library. Leading news papers in English and Marathi are subscribed and made available to the readers.

**Optimal Use of the Library:**

The optimal use of the library is ensured by providing a rich assortment of resources, research support, and a conducive learning environment. Its efficient utilization enhances learning outcomes, promotes academic growth, and cultivates a culture of intellectual exploration within the college community.

For faculty, the library serves as a treasure trove of knowledge, providing access to a vast collection of books, journals, and research papers. It supports their teaching and research endeavors, allowing them to stay updated and delve deeper into their respective fields. The library has collaborated with the central library of Shivaji University for the exchange of resources for the benefit of users of both the libraries. Researchers from various other universities and research centers approach library for access to its resources especially from rare books section.

Consistent guidance and support is provided to the students for enhancing their academic experience by utilizing the library effectively. Students have easy access to all the textbooks, reference materials, and online databases. The reading room in the library offers a quiet and conducive environment for studying, encouraging concentration and focus. The library collaborates with the Department of Library and Information Science, Shivaji University to offer Internship opportunity to BLISc or MLISc students.

**4.3 IT Infrastructure****4.3.1**

### **Institution frequently updates its IT facilities and provides sufficient bandwidth for internet connection**

#### **Response:**

The institute has always thrived to keep pace with technology and has updated its IT facilities from time to time. The institution's IT infrastructure includes hardware, software, internet bandwidth, Wi-Fi, ICT tools for the teaching-learning process, and library automation.

All the faculty members use different ICT-enabled methods and tools to provide an enhanced learning experience to the students. The ICT tools support, enhance and optimize the delivery of knowledge to students. The college has trained its faculty members and developed adequate ICT infrastructure.

Training sessions on the use of Google Classroom LMS, lecture video recording and editing have been organized for the teachers. This has helped to extend the teaching-learning process outside the physical constraints of the classroom and teachers continue to provide educational inputs to students almost around the clock. Teachers have also developed Educational YouTube channels, web portals and blogs.

- WiFi as well as LAN facility is made available to all the stakeholders on the college campus.
- Interactive panels with a wide range of illustration options are installed in three classrooms.
- LCD projectors are also installed in all the 22 classrooms to enable the audio-visual presentation of diagrams, models and documentaries to students.
- A Recording Studio equipped with an interactive panel, PTZ camera, audio recording equipment, and lighting has been developed for Content Development.
- E-resources including those available on NList, e-PG Pathshala, CEC, and NPTEL are referred to the students.
- Since the last visit of the NAAC peer team during the evaluation period, the College's IT facility has grown by leaps and bound.
- A jump in the number of desktops/laptops from 65 in 2015-16 to 120 in 2021-2022 has been seen, with 80 computers have been designated for student use.
- The number of printers has increased from 20 to 35 (of which 20 are all-in-one printers).
- From a single BSNL Internet connection with 10 MBPS bandwidth in 2001, the college campus now has three BSNL FTTH connections with 100 MBPS capacity in 2017-2018.
- Optical fibre cables connect the main buildings.
- Wi-Fi has been available for all the departments, libraries, common staff rooms, departments, and administrative offices with the help of 14 Routers.
- The number of LCD projectors has increased from **10** in 2016 to **22** in 2022.
- For benefit of teachers for online teaching three fully customized smart classrooms have been established.
- CCTV surveillance system with **15** cameras (2MP IP) established in 2017-18, currently has **104** cameras with DVRs installed for surveillance in laboratories, staff common room, canteen, gymkhana, library, and surrounding areas of all campus buildings.

**Maintenance of ICT Facilities:**

The Information and Technology Committee looks after the maintenance of the ICT facilities in the campus. The committee works in co-ordination with the AMC committee. The ICT facilities are maintained by having Annual Maintenance Contract with local technical service providers. 100 mbps optical fibre connections are maintained by BSNL, Government of India.

## 5.4 Alumni Engagement

The alumni of Rajaram College have distinguished themselves in various walks of life and have maintained a strong connect with the alma mater through 'Rajaram College Past Students Association' (RACOPASTA) which was established on 1st March 1979. As on today, nearly 5000 ex-students are the registered members of this association.

The aim of the association is to support the institution in academic development, student support and augmentation of infrastructural facilities.

#### **Academic Development:**

- a. Eminent alumni of our institution continuously interact with our present students and share their knowledge and skills, also guide them in choosing career paths. They also motivate the students to update themselves and keep abreast of latest developments in their interest areas.
- b. Mr. Vinodchandra Parikh, an alumnus of Department of English, has donated an amount for instituting a "Principal Barrister Balasaheb Khardekar Endowment Memorial Lecture Series".

#### **Student Support:**

- a. Our ex-students having their own firms / industries and NGOs have signed Memorandums of Understanding (MoUs) with the institution for conducting various activities for the benefit of present students. For example, Masters Analytical and Research Laboratory, founded by our alumni Kiran walke, provide On Job Training to our present students. Similarly, Conservation foundation of India, an NGO founded Mr. Ashish Ghevade, has signed a MoU under which he conducted a workshop on environmental consciousness.
- b. The Agnihotri prize is instituted by an alumnus in appreciation of the best all-round performance by the final year student from the faculty of arts.
- c. Our alumni have donated a number of books to the college library for the benefit of students.

#### **Mobilization of resources:**

- a. Our Alumni Association has contributed immensely in the development of 'Oxygen Park' on the campus. Hundreds of saplings have been donated and planted by the alumni. Additionally, a drip irrigation system and wired fencing was also installed with the financial contribution of the alumni. In last five years a total amount of **Rs. 11,11,950/-** has been contributed by the alumni towards these activities.
- b. A butterfly garden and medicinal garden has been developed by our alumni on the campus. For this

an amount of **Rs. 1,30,000/-** was donated by the them.

c. Several bunds and water bodies were developed on the campus for harvesting rain water with the financial support of the association.

#### Response:

Being a government institution, Hon. Minister of Higher and Technical Education, Principal Secretary, Director of Higher Education and Principal together frame policies and monitor their implementation as

well as give necessary directions for further improvement. The Principal executes the set policies in consultation with higher authorities CDC and IQAC. The academic and administrative responsibilities are assigned to the departmental heads and various statutory, academic, administrative, curricular and extracurricular committees viz. Reservation Cell, Grievance Redressal Committee, Purchase Committee, Research Committee, Admission Committee, Examination Committee, Career Guidance and Placement cell, Campus Development Committee etc.

Appointments of Teaching faculty are made through Maharashtra Public Service Commission (MPSC), while the non-teaching staff is appointed by the Regional Joint Director of Higher Education. The teaching faculty is governed by the service rules as specified in Maharashtra Civil Services Rules (MCSR) and UGC guidelines whereas non-teaching staff is regulated by rules as specified in Maharashtra Civil Services Rules alone. These service rules and procedures include promotion, career advancement, leaves; medical reimbursement etc. Besides the institution has its own code of conduct in place for ensuring smooth functioning.

Transparency and accountability are ensured in all the academic and administrative procedures such as admission, teaching-learning, examination, evaluation as well as appointments, promotion, career advancements etc. The Institutional perspective plan is devised in accordance with the vision and mission of the college. The five-year perspective plan (2017-2022) aims at incremental growth in the academic and infrastructural facilities for students. The institutional perspective plan is effectively deployed through well defined policies and procedures, proactive institutional bodies and a vibrant administrative setup.

## 6.4 Financial Management and Resource Mobilization

2. Funds received from Shivaji University for Lead College Activity.
3. Contribution towards Rajaram Mahotsav from alumni and stakeholders.

The received funds are optimally used as per the rules and regulations of State Government and other funding agencies.

For infrastructural augmentation, the budgetary proposal is jointly prepared by the concerned departments and IQAC. Then, it is submitted to the state government or DPC/RUSA.

The college receives major development assistance from DPC. In addition, the Public Work Department utilizes its funds for minor repairs and maintenance of college infrastructure. Proposals are sent to the

Director of Higher Education for technical and departmental approval. Thereafter, they are sent to the DPC for administrative approval.

For the provision of funds from the state government, a tentative budget for the next financial year is submitted to the Director of Higher Education well in advance.

#### **Internal Audit:**

The purchase committee looks after all the requisitions during the financial year following all the norms stipulated by various government resolutions. All the bills for the purchased items and services are submitted to the District Treasury Office of the Government of Maharashtra. The same are duly audited and verified by the audit section of the treasury office. Queries and objections, if any, are cleared by the college after which payments are made in the bank accounts of the concerned parties.

#### **External Audit:**

In addition to the internal audit, the following external audits are conducted periodically.

##### 1. Audit by the Departmental Senior Auditor:

The Director of Higher Education deploys the Senior Auditor for carrying out a financial audit

##### 2. Audit by the Accountant General, (AG) Mumbai:

The Accountant General deploys auditors for carrying out the audit of the entire purchase procedure and purchased items (Stock verification) and hiring of services. This procedure is generally carried out after every ten years. The audit is conducted in conformity with the Auditing Standards issued by the Controller and Auditor General of India.

#### **The mechanism for settling audit objections:**

Audit objections raised during the internal audit (Pre-Audit) are cleared immediately after which the disbursement of the payment is done. In external audits, auditing authorities send objections to the principal who ensures compliance.

After the completion of admission process, Audit Committee of the College gathers data of new entrants to analyze the proportion of male and female students. Generally, the college sees to it that equal number of male and female students are admitted. For this purpose, all the rules and regulations regarding women reservation laid down by the government are strictly followed.

**Infrastructural facilities and other provisions for Women provide infrastructural amenities, health and hygiene facilities, secure female friendly environment, etc.**

- Security guards are appointed to secure the premises and to avoid intruders from outside.
- CCTV Surveillance cameras are installed in the premises
- Residential facility for girls is provided and a warden is appointed to ensure security of girls.
